RE: AAFM Revoking Authority and Termination of: Dubai Chapter and Brett King

Dear Honorable Officials, Certified Members, and Officers in Asia

This letter is to inform Honorable Officials and governmental authorities that the AAFM Board of Standards has revoked ALL recognition of the Training Chapter in Africa or Dubai and terminated any recognition of Mr. Brett King or his Training attempts. Furthermore, we do not approve or authorize Mr. Brett King to issue any unregistered certificate, certification, diploma, logo, or any academic award while pretending to use our AAFM name. Please note that Mr. King quit from the AAFM network and King personally signed his own legal termination letter in writing.

The Multi-Billion dollar company, Informa Global and IIR ME Dubai <a href="www.iirme.com">www.iirme.com</a> has replaced our old Chapter Authority in Dubai and IIR Global now supervises the issuance of secure certifications in select Middle East regions such as Dubai. Therefore, only graduates of official AAFM training programs would be eligible to apply directly to the AAFM Board of Standards for Certifications, Charters, Qualifications, and Designations.

Furthermore, we must warn you to not accept fake email, faxes, or phone calls from Dubai or Africa claiming to represent ourselves or The American Academy - AAFM. We are sending a copy of this legal notice to the AAFM Global Board Members and Presidents of AAFM Regions for their records. Please feel free to send a copy of this information to relevant authorities as a consumer warning. This letter also officially revokes any recognition for Mr. King and associates in China, Singapore, HK, Taiwan, Vietnam or any other country. To be clear, any offers or solicitations from the 3 week old, unregistered iAFM African company should be ignored as spam or phishing.
